

### FIRST AID TREATMENT:

IF SWALLOWED AND PATIENT IS CONCIOUS, give 1 glass of water and induce vomiting by tickling back of threat or back of tongue with finger. Repeat procedure until vomit fluid is clear. Note: Never give anything by mouth to an unconscious person.

IN CASE OF SKIN CONTACT, remove contaminated clothing and wash affected areas with plain soap and water. If inhaled, remove from exposure area and bring patient to fresh air. If breathing has stopped, apply artificial respiration. If eyes are contaminated, Flush affected eyes with clean running water for at least 15 minutes. If symptoms persist, bring patient to the nearest medical clinic.

NOTE TO THE PHYSICIAN: The active ingredient of this product is a CNS ganglionic blocker. In case of severe exposure give intravenous injection of 100-200mg of L-cysteine or an intramuscular injection of 20-60 mg of BAL (dimercaprol or 2,3 dimercapto-1-propanol) Apply steroids against dermatitis.

MIXING: ADABlast Cartap 50 SP is generally recommended to be applied at the rate of ½ to 1kg product in 300-600 liters water per hectare. For specific pest and crop, consult the dilution guide above.
