DIRECTIONS FOR USE:

Level field properly. Irrigate rice field to allow snails to surface out and maintain 3 cm depth of water.

Spray ADAClear 70 WP at 350 grams per hectare. Do not irrigate further for at least 48 hours. Follow standard irrigation practice after this treatment.

Frequency & Method of Application:
